UPDATES ON THE CONTEMPT PROCEEDINGS

*Unless otherwise stated, capitalised terms used herein shall bear the same meaning ascribed to them in the announcement dated 28 November 2019 ("**28 November 2019 Announcement**") and the announcement dated 3 October 2022 ("**3 October 2022 Announcement**").*

RHT Health Trust Manager Pte. Ltd. (in its capacity as trustee-manager of RHT) (the "**Trustee-Manager**") refers to the 28 November 2019 Announcement, the announcements dated 4 February 2020, 16 March 2020, 30 June 2020, 6 July 2020, 4 August 2020, 20 August 2020, 14 September 2020, 23 September 2020, 16 October 2020, 23 November 2020, 3 December 2020, 29 January 2021, 19 February 2021, 26 February 2021, 5 March 2021, 11 March 2021, 19 March 2021, 26 March 2021, 14 May 2021, 31 May 2021, the 3 October 2022 Announcement and the announcement dated 25 October 2022.

The Trustee-Manager wishes to update that the hearing in respect of the execution proceedings before the Hon'ble High Court of Delhi ("**High Court**") had taken place on 6 December 2022. In this hearing, the High Court heard submissions from parties on the applications filed by Daiichi Sankyo Company Limited ("**Daiichi Sankyo**"). After hearing the parties, the High Court directed Daiichi Sankyo to prepare and file a convenience chart setting out the details of all pending applications and the steps taken or pending in such applications, ahead of the next hearing. The High Court directed that the matter be listed for further hearing on 16 January 2023.

At the hearing on 16 January 2023, it was ordered that the matter may be placed before the Hon'ble Judge-In-Charge (Original Side) of the High Court for placing the matter before an appropriate Bench for further consideration and hearing. This was on account of a change in the roster for the High Court on 9 January 2023. Accordingly, no effective hearing took place on 16 January 2023 and the matter was listed for further hearing on 20 January 2023.

Thereafter, the matter was placed before a new Bench. On 20 January 2023, the High Court heard the applications and ordered that the matter be listed for further hearing on 7 February 2023. In the meantime, the High Court directed all the parties to file a common convenience compilation of all the applications, replies and rejoinders filed before the High Court in a chronological order within a period of one week from 20 January 2023. Further, the High Court also directed Daiichi Sankyo to file a compilation of the relevant orders of the Supreme Court of India passed in the Contempt Proceedings at least 48 hours prior to the next hearing date i.e., 7 February 2023.

The Trustee-Manager will continue to monitor any further developments in respect of the Contempt Proceedings and matters ancillary thereto and will make the appropriate announcement(s) on SGXNET as and when there are any material developments.
