UPDATES ON THE CONTEMPT PROCEEDINGS

*Unless otherwise stated, capitalised terms used herein shall bear the same meaning ascribed to them in the announcement dated 28 November 2019 ("**28 November 2019 Announcement**") and the announcement dated 3 October 2022 ("**3 October 2022 Announcement**").*

RHT Health Trust Manager Pte. Ltd. (in its capacity as trustee-manager of RHT) (the "**Trustee-Manager**") refers to the 28 November 2019 Announcement, the announcements dated 4 February 2020, 16 March 2020, 30 June 2020, 6 July 2020, 4 August 2020, 20 August 2020, 14 September 2020, 23 September 2020, 16 October 2020, 23 November 2020, 3 December 2020, 29 January 2021, 19 February 2021, 26 February 2021, 5 March 2021, 11 March 2021, 19 March 2021, 26 March 2021, 14 May 2021, 31 May 2021, the 3 October 2022 Announcement, and the announcements dated 25 October 2022 and 30 January 2023.

The Trustee-Manager wishes to update that further hearings in respect of the execution proceedings following the order dated 22 September 2022 passed by the Supreme Court of India in the Contempt Proceedings were held on 7 February 2023 and 16 February 2023.

At the hearing on 7 February 2023, Daiichi Sankyo Company Limited ("**Daiichi Sankyo**") had summarised the various pending applications for the Hon'ble High Court of Delhi ("**High Court**"), which included the application to seek the appointment of forensic auditors to analyse the transactions entered into between Fortis Healthcare Limited, RHT and other related transactions (the "**Forensic Audit Application**"). The High Court was unable to hear substantive arguments on the various applications and directed the parties to complete their pleadings in the applications before the next hearing date on 16 February 2023.

At the hearing on 16 February 2023, the High Court heard substantive submissions of the parties on certain other applications filed by Daiichi Sankyo (other than the Forensic Audit Application). However, the submissions could not be concluded at the hearing and the High Court had adjourned the matter (including the Forensic Audit Application) for further hearing on 2 March 2023.

The Trustee-Manager will continue to monitor any further developments in respect of the Contempt Proceedings and matters ancillary thereto and will make the appropriate announcement(s) on SGXNET as and when there are any material developments.
